ACEPHATE PRO 75 SP is an insecticide for control of fire ants. The active ingredient in ACEPHATE PRO 75 SP is acephate, a water soluble insecticide readily absorbed by plant roots and foliage to give systemic control of feeding insects. Insect pests are generally controlled more effectively by ACEPHATE PRO 75 SP through ingestion than by contact. Application of ACEPHATE PRO 75 SP to maintain control should be repeated only as directed.

Do not apply under conditions involving possible drift to food, forage or other plantings that might be damaged or the crops thereof rendered unfit for sale, use or consumption.

NOTE: This product is sold by weight and package is full when packed, but due to the product's nature, settling is likely to occur.
